-  **Sunset Pocket Park** - 1642 Cass Lake Road ▪ Pedestrian and cyclist resting spot in the streetscape along Cass Lake Rd with view of Cass Lake.
-  **Webb Pocket Park** - 1721 Cass Lake Road ▪ Pedestrian and cyclist resting spot in the streetscape along Cass Lake Rd.
-  **Fireman's Pocket Park** - 1933 Cass Lake Road ▪ Pedestrian and cyclist resting spot in the streetscape along Cass Lake Rd.
-  **Grove Street Swim Site** - Willow Beach St & Grove St on Cass Lake ▪ Local swim access to Cass Lake for Keego Harbor residents. No parking. Sandy beach, shallow water. Picnic table.
-  **Fran Leaf Park** - 2138 Brock Street ▪ Public park with canal, playground equipment, picnic shelter. Parking for 6-8 cars. Footpath to Willow Beach swim site.
-  **Rose Sortor Park** - 2998 Knowlson Street ▪ Town gathering area behind City Hall. Pond, cinder trail, gazebo, picnic tables, fountain. Parking for 10-12 cars
-  **Baxter-Morgan Park** - 3195 Pridham Street ▪ Public park with extensive playing fields, picnic shelter, tables, playground equipment. Suitable for large gatherings. Limited parking.
-  **Hester Court Park** – at the south end of Hester Court St & Virginia Ct ▪ Public park with picnic shelter, tables, swing set, large playing field. Suitable for large gatherings. Access to West Bloomfield Trail. Parking for 6-8 cars.
-  **Tate-Optimist Park** - 3245 Rycroft ▪ Public park with picnic shelter and tables, playground equipment. No parking. Access to West Bloomfield Trail.
-  **Willow Beach Swim Site** - Willow Beach St & Park Circle on Cass Lake ▪ Local swim access to Cass Lake for Keego Harbor residents. Sandy bottom, shallow water, no parking. Summer day camp activities are held here. Footpath from Fran Leaf Park which has parking.
-  **Veteran's Memorial Pocket Park (the Rock)** - Cass Lake Rd south of Orchard Lake Rd, in the boulevard. ▪ Pedestrian and cyclist resting spot in the streetscape on Cass Lake Rd.
