City Park Inspections: Commissioners are to meet at City Hall, at noon, April 13th.

Sunken Sidewalk in Fran Leaf Park: Treasurer Leslie Clark describes a plan to install a walkway made from recycled composite Trex deck system components, to be installed over the existing sidewalk. This would be a much-needed affordable and relatively quick fix to a much-needed flooding situation in Fran Leaf Park. It would be a plank on a rail system and would raise the walkway by 2". She has already found some supplies as a free donation and would like to present this to the city council and move forward with it as soon as approved and possible.

#### **OLD BUSINESS**

Canal Clean up: Treasurer Leslie Clark describes the Fran Leaf Canal as well maintained by the neighbors this year. In exchange for their efforts, they would like to see some of the trash removed from the canal. She also proposed a plan to move sand from the mouth of the canal into sandbags, then moved to the bank of the canal on Brock Street, to help

prevent flooding into the neighbors' driveways. No permits are needed in this situation for the sandbags. This idea had much discussion.

**FY 24-25 Budget:** Chairperson Kirsten Sonneville-Douglass presented a recap of the events already in place and then went on to present more ideas under a new name" Keego Konnect" including yoga, Painting in the park, Disc Golf popups, an adult scavenger hunt, and Earth Day. Halloween Dance for kids and adults, adults costume party, and Gino's, with a DJ, were also in the discussion. There was some discussion on a Disc Golf sponsorship program for the newly installed course in Baxter Morgan Park.

Chairperson Kathleen Sexton presented ideas for Commissioner Julie O'Brien and herself for events in the fall. A gathering place for the kids in Rose Sortor Park, with pumpkin painting, scavenger hunt, trick or treat around the pond, nature table, and a wagon parade, much like Candyland was discussed. Spooky music playlist and cider and donuts would be included. An invitation to the ArtSail group to participate was extended. Commissioners Kathleen Sexton, Julie O'Brien, and Amy Drain plan to co-chair this event with a projected budget of \$466.00 to \$666.00.

Parking Discussion at Baxter Morgan Park: Commissioner Julie O'Brien presented 3 professional layouts of what the parking should and could be. As it stands, with the space available, there is currently no way to install an up-to-code parking lot without upgrades to the property. What needs to change to make it happen was also discussed.

Egg Hunt: Commissioner Jaky Van Dox expressed her opinion that the number of eggs to use for the egg hunt has grown to "overkill" and the budget is almost double what is allotted for the Halloween Parade Kid event. She offered her opinion to throw out the broken eggs and not replace them going forward and to reduce the budget for the event. City Manager Tammy Neeb and Treasurer Leslie Clark answered her questions about starting and set-up time for the event. West Bloomfield Library will be at the event.

Memorial Day Parade: Chairperson Kirsten Sonneville-Douglass reported that the permits are submitted and waiting for approval. City Manager Tammy Neeb reported that the bus credits are available at a better rate this year.

**Community Garden:** City Manager Tammy Neeb needs a layout for the garden to make sure they do not give out an occupied space. Secretary Robin LaFrance has the dimensions of the garden and will send a layout of the garden.
